### **BLUE LODGE OF THE YEAR 2020-2021**

**Nominees for The M.W.P.H.G.L. Blue Lodge of the Year Award must satisfy the following criteria in order to be considered.**

- Shall be in good and regular standing with the Grand Lodge.
- Shall be a visible and active participant in the activities and programs of their local community.
- Shall have made charitable and benevolent contributions to various community and religious endeavors.
- Shall have worked in conjunction with a fortress of TraiMasters, or some type of mentoring program involving African American youth.
- Shall have no members of the lodge whom are not in good standing (suspended, expelled, etc...) with the Grand Lodge.
- Shall in all ways, and at all times, promote the highest ideals of Freemasonry.

### **MASTER MASON OF THE YEAR 2020-2021**

**Nominees for The M.W.P.H.G.L. Master Mason of the Year Award must satisfy the following criteria in order to be considered.**

- Shall be a member in good and regular standing with his local Blue Lodge.
- Shall have participated and contributed at the Grand Lodge level.
- Shall have demonstrated distinguished service to his local Blue Lodge through committees, charitable endeavors, etc...
- Shall have demonstrated notable accomplishments and achievements in civic, religious, and professional endeavors.
- Shall demonstrate adherence to the tenets of free masonry; brotherly love, relief and truth.

### **DISTRICT DEPUTY GRAND MASTER OF THE YEAR 2020-2021**

**Nominees for The M.W.P.H.G.L. D.D.G.M. of the Year Award must satisfy the following criteria in order to be considered.**

- Shall be in good and regular standing in his local Blue Lodge.
- Shall visit all Lodges within his district on a regular basis, and report to the Grand Master the status of those lodges.
- Shall submit letters of commendation/recommendations from Lodges within his district supporting his nomination for this award.
- Shall indicate how the Lodges within his district work together in peace, harmony, and unity (joint picnics, joint Saint John's Day programs, fund-raisers, initiations, etc...)
- Shall make detailed and thorough district reports at all Grand Communications, or whenever called upon at the pleasure of the Grand Master.
